ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Peruvian Inca Orchids, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Silken Windhounds and Whippets may be entered in the regular stakes.

Provisional breeds may be entered in the Provisional Stake or the Singles Stake. Provisional breeds are listed on the ASFA website and must be individually registered with the appropriate registry.

All entries in the regular stakes shall be individually registered with the American Kennel Club, the National Greyhound Association (NGA), including the United Kennel Club (UKC), the Federation Cynologique Internationale (FCI), an ASFA-recognized foreign or ASFA Board approved registry or possess a critique registration number (CRN) from the Society for the Perpetuation of Desert Bred Salukis (SPDBS). Provisional stake entries shall be individually registered with the appropriate registry. (Dogs with an Indefinite Listing Privilege (ILP) or Purebred Alternate Listing (PAL) from the American Kennel Club shall be considered registered with that body.)

REGULAR STAKES OFFERED

OPEN STAKE: Any eligible sighthound, excluding ASFA Field Champions of record that has met the certification requirements.

FIELD CHAMPION STAKE: Any ASFA Field Champion

VETERAN STAKE: any eligible hound whose age is at least six years, except Irish Wolfhounds, whose age shall be at least five years, and Afghan Hounds, Ibizan Hounds, Rhodesian Ridgebacks, Salukis, and Whippets, whose age shall be at least seven years. That has obtained an ASFA certification, AKC QC, or other qualifying waivers prior to the closing date. A copy of the certificate MUST be submitted with the entry forms. Points go toward V-FCh or V-LCM titles.

PROVISIONAL STAKE: Any eligible sighthound of a Provisional breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLES STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake.

Conditions of Entry: All entries must be one year or older on the day of the trial ● Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more ● Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. ● Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake ● Hounds not present at the time of roll call will be scratched ● All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified. ● Any hound that displays aggressive behavior during trial hours will be excused for the day without refund of entry fee. ● A penalty of \$5.00 will be assessed for any loose hound not competing in the course in progress. ● A penalty of \$5.00 will be assessed for any waste material left of the grounds by a dog or person. 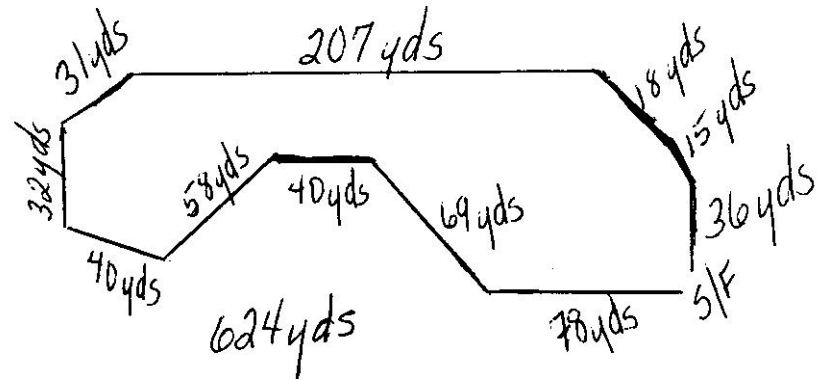

DIVISIONS AND STAKES OFFERED

RACE has created the following stakes and divisions for all RACE-sanctioned lure coursing trials:

Breed Divisions and Mixed Divisions: The minimum number of dogs required to make a Breed Division is two dogs of the same breed. Where there are fewer than two dogs of one breed entered, the dogs shall be grouped into Mixed Divisions (see next subsection). Mixed divisions shall consist of at least two dogs of similar breed or type.

Open Stake: Any eligible breed or mixed-breed, excluding AOK9 Lure Coursing Champions of record, that has met the certification requirements.

Senior Stake: Any eligible breed or mixed-breed dog who have attained the age of 8 years or older as of the date of the trial, except for giant breeds which have attained the age of 5 years or older. Dogs entered in the Senior stake must have met certification requirements as set forth in these Rules within one year preceding the trial, and may not be entered in the Open or any other stake in the same trial. Dogs of an age which make them eligible for the Senior stake may be entered in the Open stake at the option of the owner. Trials in which a dog is entered in the Senior stake will not be included in the trials counted in determining whether the dog earns any title.

Special Stakes: The host club shall have the option of offering the following special stakes: Bitches Stake (females, all age) and Dog Stake (males, all age). The special stakes will be broken into breed or mixed divisions depending on the entry. Dogs entered in Special stakes must have met certification requirements as set forth in these Rules within one year preceding the trial. A host club offering these Special stakes may, at its option, offer Special stakes in lieu of offering an Open Stake. Trials in which a dogs is entered in a Special stake will be included in the trials counted in determining whether the dog earns any title, so long as the requisite number of dogs is entered in that stake. **Singles Stake:** Any eligible breed or mixed-breed may be entered in Single stakes. Dogs entered in this stake shall run the course alone, and need not have met certification requirements, but must have attained the age of 1 year or older as of the date of the meeting. Trials in which a dog is entered in the Singles stake will not be included in the meetings counted in determining whether the dog earns any title. **Breeder/Kennel Stake:** The host club shall have the option of offering a Kennel and/or Breeder Stake. These shall be "virtual" or "paper" stakes, eligibility requirements and placement protocols for which shall be set by the host clubs offering them.

Flights: For trials in which the brace elimination format is being used, when the entry in any stake (for the breeds being run in that format) reaches 9 dogs or more, the stake will be split into flights, as evenly as possible, by random draw. There shall be a minimum of 4 dogs in each such flight unless the entry is lower than 4. For trials in which the scored braces or scored trios format is being used, when the entry in any stake (for the breeds being run in those formats) reaches 20 or more, the stake will be split into flights, as evenly as possible, by random draw. There shall be a minimum of 10 dogs in each such flight.

Conditions of Entry: All entries must be one year or older on the day of the trial • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more • Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. • Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake • Hounds not present at the time of roll call will be scratched • All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified. • Any hound that displays aggressive behavior during trial hours will be excused for the day without refund of entry fee. • A penalty of \$5.00 will be assessed for any loose hound not competing in the course in progress. • A penalty of \$5.00 will be assessed for any waste material left of the grounds by a dog or person. This also includes trash. Waste and trash disposal equipment and containers will be available.

Equipment: Type of lure machine: battery-powered drag system. • Type of lures: highly-visible white plastic strips • Back-up equipment will be available.

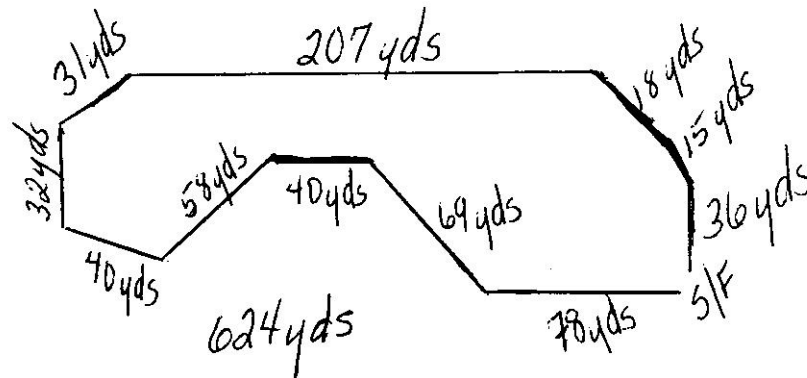
